UPDATE: Monday 27th September 2021.

Refer to the Bowls Vic website for the most up to date information.


NB: MWBC will also be required to comply with City of Monash reopening requirements.








# 2021/22 Season Opening Breakfast

The Opening Breakfast remains on the postponed list. We are awaiting confirmation of when we will be able to hold the event.





**Dear President or Secretary** 

Re: Southern Indoor Bowling Club (SIBC) – Proposed distribution of funds

I write to advise that at the AGM of SIBC held on Wednesday 28<sup>th</sup> August 2019, the members approved a distribution scheme in respect to the funds to be received from the sale of the SIBC property at 350 Hawthorn Road, Caulfield South.

The Constitution of SIBC provides that <u>upon a winding up or dissolution of the Club</u> that any property remaining after the payment by the Club of its debts and liabilities "<u>shall be given or transferred to some other organisation having purposes similar to the purposes of the Club and which prohibits the distribution of its or their income and property amongst its or their members and which is also not carried on for the profit or gain to its members."</u>

As your club appears to meet the pre-requisites laid down in the SIBC Constitution, it is anticipated that your club will be eligible to participate in the distribution scheme, upon a winding up of SIBC, and subject to your club meeting various requirements detailed later in this letter.

The SIBC Board considers that any grant received by a club should be used primarily for the purposes of the promotion and playing of the sport of bowls and specifically for the enhancement of physical and financial infrastructure in and around your club, marketing of your club and as a negotiating tool in any merger discussions your club may seek to have with other clubs.

To participate in the distribution scheme once SIBC has been wound up, the SIBC Board has laid down the following pre-requisites to be met:

- 1. A Solicitor's Certificate in the form **attached** to this letter which:
  - a. certifies that your Club has similar purposes to the SIBC, namely the purposes set out in Clause 3 of the SIBC Constitution;

- b. certifies that its Constitution prohibits the distribution of its income and property amongst its members and is not carried on for the profit or gain of its members;
- c. certifies that its Constitution otherwise complies with the provisions of the *Associations Incorporation Reform Act 2012*.
- 2. An agreement in writing to accept a plaque which acknowledges the grant from SIBC, with such plaque to be displayed in a conspicuous and prominent position at your Club's premises.
- 3. A Statutory Declaration in the form **attached** from the President or Secretary of the Club (which has been approved by the resolution of the Board of your Club) certifying that a membership list attached to the Statutory Declaration is a full and exhaustive list of all SIBC members of your Club as at 30 November 2018. To assist your club, please see **attached** a copy of the SIBC membership and our understanding of their club affiliations as at 30 November 2018.

If more than one club claims an SIBC member, the primary club of the member will receive the grant related to that member. We will contact you if this provision affects you.

### Please note:

- a) We request that you complete the attached Club Registration & Authority Form and return it by no later than 14 October 2019 by email to: secretary@southernindoorbowls.com.au;
- b) The requirements as outlined in paragraphs 2 to 3 are to be completed by your club by no later than **30** October **2019**;
- c) The required solicitor's certificate is to be fulfilled at a later time; the timing of this will be requested of you in writing.

In addition to the above matters we also advise that certain items of equipment that are currently utilised by SIBC will be available to other clubs shortly prior to settlement of the sale of the clubs' Hawthorn Road premises. These items include office equipment, tables and chairs, honour boards, a large trophy case, workshop tools etc. A full inventory of assets and equipment will be distributed in June or July 2020 and will be made available to all clubs. Clubs are then invited to register their interest in such items by email or letter to the SIBC Secretary.

SIBC otherwise reserves its rights to audit your club's constitution and memberships or membership list or delegate such audit to an external auditor.
